FRESH BOOST AT AFCDP

The French Association of Data Protection Correspondents recently renewed its board of directors

This renewal brings in the representatives of large organizations such as Areva (worldwide leader in nuclear and renewable energies), Groupe Casino (retail and supermarket chains), ESSEC (organization of business schools), Groupama (insurance company) and La Poste (national postal services).

They will share their enthusiasm with the re-elected candidates, including the representative of Banque de France (French national central bank) and the Correspondent of Notaries.

The AFCDP board now counts 2/3 of officially designated Data Protection Correspondents ("so-called "CIL", "*Correspondants Informatique et Libertés*") and 1/3 of women.

The board re-appointed as President Monsieur Paul-Olivier Gibert, Compliance manager and CIL of the insurance group AG2R – La Mondiale.

The new board will implement an ambitious development plan for its four-year term :

- AFCDP workshops will continue to work on events and deliverables. On **October 13**, AFCDP will pitch at the e-commerce/distant selling symposium in Lille on the key points to take into consideration for the implementation of a CRM system. It will also soon issue guidelines for the Data Protection Correspondent to be ready in case of investigation by the CNIL, the French data protection Authority. With the creation of a new workshop "Health data" and "Insurance-Retirement plans", the AFCDP will consider the impact of a security breach notification obligation, in anticipation of its potential introduction.
- The AFCDP President also wants to develop the activities of the association in region: "*Data protection correspondents often feel lonesome. We organise regular meetings with our active members in Strasbourg, Lyon, Lille and Marseille. We will soon organize meetings everywhere in France*".

- On a political standpoint, the AFCDP, after its hearing by the Senators Yves Détraigne et Anne-Marie Escoffier (who wrote the report « privacy at the time of digital memories ») will organize a series of breakfast meetings to debate on the following : « The DP Act is more than 30 year old, the data protection directive almost 15 and the CIL almost 5. We must get ready for a potential evolution so that the role of Data Protection Correspondent be fully recognized”.
- The new team will also consolidate its sister relationship with its foreign counterparts, including IAPP and GDD, and its international contacts initiated during its 5th annual conference on the theme of Data Protection Officers in Europe and elsewhere. The AFCDP is in particular active in the organization of the IAPP workshop which will be held in Madrid on **November 3** before the International Conference of Data Protection Commissioners, where Paul-Olivier Gibert (President) will represent the association and Pascale Gelly (Board member) will chair a workshop.
